- The remote e-voting facility was made available from, 24<sup>th</sup> January, 2024 (9:00 A.M.) to 28<sup>th</sup> January, 2024 (5:00 P.M.) for the person(s), whose names were recorded in the Register of Member or in the Register of Beneficial owners maintained by the depositories as on the cut-off date i.e. Monday, 22<sup>nd</sup> January 2024.
- The Company provided the e-voting facility for the members to vote during the EOGM who attended the meeting through VC/OAVM and had not cast their vote through remote e-voting. The Members who had already cast their vote through remote e-voting were entitled to attend the EOGM but not to cast their vote again at the EOGM.
- After the conclusion of the e-voting period, the votes cast by the members through VC/OAVM
  and through remote e-voting facility, were downloaded from the e-voting website of the CDSL in
  presence of two witnesses viz. Ms. Deepika Sharma and Mr. Akhil Bansal, who are not in the
  employment of the Company.
